#### Chapter's Spring-Summer 2021 PMs in the AM



Two words accurately describe the sessions offered for PMs in the AM during the months of April, May, June and July –information packed! Participants were introduced to topics that we don't typically consider in our day-to-day project management, but we learned that the future (and present) are impacted by them. From minecraft and artificial intelligence to smart homes, J. Scott Christianson led us through a series that provided insight into the workings behind these technology advancements and also how directly they can affect our

projects and how we manage them.

J. Scott Christianson is a long-time member of the chapter, but also an entrepreneur, speaker, and professor at the University of Missouri College of Business. We were fortunate to have him lead these sessions this year. Scott has thousands of followers on LinkedIn, and you can be one of them!

## The Mathis Group Project Recovery Workshop Takeaways By Kevin McDaniel, PMP

In June this year I was able to participate in the Project Recovery workshop presented by The Mathis Group. The workshop was very informational, and provided a deeper dive into all aspects of what a project recovery effort should entail. The course covered detailed steps on 1) When to know that you need to begin project recovery and 2) What steps you need to take in order to get your project back on track. We were provided with an outlined process detailing each step.

There were a couple of highlights that resonated with me specifically. The first one was the utilization of analytical tools to help in determining project recovery that went beyond basic root cause analysis. The second was that management support or lack of support is crucial in both keeping projects on track, and also providing support in getting resources needed to perform a proper project recovery.

There are already a couple of items from this workshop that I have put to use in my day-to-day management of projects. The first has already been in place for our project management team, and that is the use of dashboards. The dashboards allow us in real time to see status of projects along with status reports to provide visual signals where issues may be occurring. The second technique I have started to use for some of my problem projects is going through the 3 P's (People, Process, Performance) and asking the relevant questions in each topic as it pertains to project team members, the process being used, and how we are tracking performance.

I appreciated the opportunity to attend this workshop, and I found it relevant to my current projects so could immediately begin to take actions to address problems.
